

CVOA HALL OF FAME NOMINATION

The Colorado Volleyball Officials Association invites all our members to make nominations of deserving officials, coaches, administrators, and athletic contributors for consideration into the CVOA Hall of Fame.

Certain criteria are required for the applications to be accepted and the individual's name placed on the list for consideration. Please read the instructions carefully before submitting the nomination.

Completed nomination forms may be submitted by email to the **CVOA Executive Committee**.

All nominations must be submitted by July 1 to be considered for a vote at the CVOA Annual Business Meeting.

1. Description of information supporting reason for nomination of official.
2. Complete general information.
3. Enclose letters of recommendation or support if any.
4. Concentrate on nominee's **high school volleyball officiating achievements**.

NOTE: Be sure to provide as much information as possible to ensure your nominee gets full consideration.

Nominees that have not been selected after five years will be purged and must be re-nominated to be considered for induction.

OFFICIAL: A person who has made a significant contribution to the ideals, mission, and betterment of CVOA, its members, and high school volleyball. An official is eligible for consideration after a minimum of fifteen years of service.

Criteria to be considered:

1. Number of years officiating high school volleyball
2. Positions held as an officer of CVOA
3. Post season experience
4. Additional information that qualifies this individual for consideration as a CVOA Hall of Fame Nominee

OTHER: Any person/group whose activities and/or combination of activities have resulted in a service qualified as outstanding or excellent. This service must have been provided to CHSAA or CVOA. Such a person/group is eligible for membership after a minimum of ten years of service.

Only nominees that meet these criteria will be considered for selection into the CVOA Hall of Fame.

Only achievements and accomplishments related to high school volleyball will be used in determining selection.
